Author Guidelines

GENERAL INSTRUCTIONS:

- Abstracts should report original research.
- Documents that do not follow the guidelines will be rejected.
- Documents received after the given deadline, due to any reason, will not be accepted unless the deadline is extended.
- The word limit should not exceed 300 words.

FORMAT FOR ABSTRACTS:

- Paper size and Orientation: **B5** portrait
- All margins except left: 1". Left margin: 1.25". Gutter: 00
- Font: Times New Roman, 11 points; Line spacing: 1, one column of text.
- No Header or Footer except 15 mm Footer for page numbering
- All the details should be arranged on one page (strictly follow the formatting guidelines)

• Title

- o Font type and size: Times New Roman, 14
- Centred text in bold
- Title Case
- O Abstract titles should be short but descriptive. Informative titles, indicating key points are encouraged. Abbreviations should not be used in the title. Scientific names must be in italics.

Affiliations

- o Font type and size: Times New Roman 11
- Names should be indicated with superscript Arabic numbers appearing at the end of surname/family name.
- A superscript asterisk should be used for the corresponding author
- Names of affiliations should be given, including the country
- O If there are more than one name and address, they should be related by superscript numbers
- o The corresponding author's email address should be included

Abstract

The abstract should contain an introduction to the study with the objectives, methodology, and results, followed by a short discussion and a conclusion(s) presented in a single paragraph without subheadings or references. Use only the SI units. Keep a single space between two types of units (e.g. J mol⁻¹ K⁻¹). Use negative exponent (e.g. kg m⁻³) and do not indicate units as divisions (e.g. kg/m³). Chemical formulae should be written in a standard form such as "CaCO3", not as "CaCO3". Use a zero before decimal points such as "0.45," not ".45." Keywords should be given, leaving one-line space below the text.

Keywords: Keyword 1, keyword 2, keyword 3, keyword 4, keyword 5 (should be arranged in alphabetical order)

Abstract

The abstract should be written in Times New Roman, with 11pt font, and the document should be single-line spaced. The word limit should not exceed 350 words. The document should not exceed one page. Top, Bottom and Right margins of the page should be set to 1", and the left margin should be 1.25". The fonts, sizes and styles for the title, names of authors and affiliations should be as shown above. The paragraph should be Justified, no indent, no extra spacing before or after the paragraph and no special effects. The name of the presenting author should be underlined. The corresponding author should be identified with a <*> sign above the author's name, and his/her email address should be provided as indicated above. Abstracts should be submitted in Microsoft® Word format. Do not include section headings in the abstract. Citations, References, Figures and Tables should not be included in the abstract.

Keywords: Please add a maximum of five keywords separated by commas, shouldbe in italics, 11pt. Keywords should be presented in alphabetical order.
